DRESS CODE ENFORCED: COWBOY HAT, BOOTS AND LONG OR SHORT SLEEVE SHIRT W/COLLAR. (NO TANK TOPS, TEE SHIRTS OR BALL CAPS) ALL EVENTS ARE DRAW EXCEPT FOR THE LADIES. CALF BRANDING. YOU CAN PICK AND LADIES CAN ENTER THE LADIES AND/ THE OPEN CALF BRANDING. YOU CAN ENTER ONCE IN EACH EVENT.

TIMES WILL BE PROGRESSIVE AFTER HI-TIMES HAVE BEEN ESTABLISHED IN THE CALF BRANDINGS, CATTLE SORTING, CUT & ROPE AND THE RANCH DOCTORING. IF THERE ARE ANY QUESTIONS REGARDING THE RULES ASK THE FLAGGER BEFORE THE EVENT BEGINS. MAKE ENTRY ON RANCH RODEO ENTRY FORM. ONE ENTRY PER PERSON. ALL ENTRY FEES MUST BE INCLUDED BY THE DUE DATE FOR ENTRIES TO BE ACCEPTED. THERE WILL BE A ONE TIME OFFICE CHARGE OF \$5.00 PER CONTESTANT. ENTRIES CLOSE NOVEMBER 10, 2011

SALINAS VALLEY FAIR RANCH RODEO RULES

OPEN CUT AND ROPE: TWO PERSON TEAM. TIME WILL START WHEN YOU CROSS THE FLAGGER LINE AND A # WILL BE GIVEN. YOU MUST GET THE CORRECT NUMBER ANIMAL ACROSS THE LINE FIRST BEFORE YOU CAN HEAD IT. YOU CAN HEEL IT ANYWHERE IN THE ARENA. IF ANY NUMBER OTHER THAN THE NUMBER CALLED COMES ACROSS THE LINE FIRST, YOU WILL BE FLAGGED OUT. 5 SECOND PENALTY FOR A FRONT OR ONE HIND LEG. THREE LOOPS ALLOWED. 3 MINUTE TIME LIMIT. PROGRESSIVE AFTER TIMES ESTABLISHED FOR PAYOUT AND POINTS.

OPEN CATTLE SORTING: THREE PERSON TEAM. TIME WILL START AND A NUMBER WILL BE GIVEN WHEN THE FLAGGER DROPS HIS FLAG. CATTLE MUST CROSS THE LINE IN # ORDER. ANY WRONG NUMBER CATTLE YOU WILL BE FLAGGED OUT. 3 MINUTE TIME LIMIT. PROGRESSIVE AFTER TIMES ESTABLISHED FOR PAYOUT AND POINTS.

OPEN RANCH DOCTORING: A TEAM WILL CONSIST OF 4 DRAWN CONTESTANTS. TIME WILL START AND A NUMBER GIVEN AS YOU CROSS FLAGGER LINE. YOU BRING OUT YOUR NUMBER AND AFTER IT CROSSES FLAGGER LINE YOU HEAD AND HEEL IT. NO OTHER CATTLE MAY CROSS THE LINE AHEAD OF YOURS. EACH TEAM MEMBER CAN USE ONE LOOP TO ROPE. ONCE ROPED, MUST PLACE ROPES LIKE CALF BRANDING AND MARK WITH CHALK ON HEAD. RAISE HANDS TO DECLARE TIME. EACH TEAM MEMBER WILL HAVE CHALK. NO TIME LIMIT. PROGRESSIVE AFTER PAYOUT AND POINTS TIMES ESTABLISHED.

OPEN CALF BRANDING: A TEAM WILL CONSIST OF 4 DRAWN CONTESTANTS. EACH TEAM WILL ROPE 4 CALVES TOTAL. THEY WILL SWITCH IN THE PEN AFTER 2 CALVES. TIME LIMIT IS 4 MINUTES. CATTLE MUST BE HEADED, HEELED AND DALLIED BEFORE GROUND CREW CAN LEAVE PAINT CAN AREA. TEAM WILL BE FLAGGED OUT IF GROUND CREW LEAVES DESIGNATED AREA, EXCEPT TO TAKE OFF ILLEGAL CATCHES OR LOST ROPES. LEGAL CATCHES IS NECK W/ FRONT FOOT OR A FIGURE 8 W/FRONT FOOT. INCORRECT BRANDING IS IMMEDIATE DISQUALIFICATION. BRANDING IRON MUST BE RETURNED TO THE POT IF CALF BECOMES LOOSE. THEN BROUGHT BACK ONCE ROPES ARE TIGHT. IF CALF GOES THROUGH OR OVER FENCE BECAUSE OF UNNECESSARY ROUGHNESS TEAM WILL BE FLAGGED OUT. IF FAULTY EQUIPMENT, CALF WILL BE BROUGHT BACK AND TIME WILL START LAP AND TAP.

OVER 50 CALF BRANDING: WILL ROPE 2 CALVES. TEAM WILL PICK THERE OWN GROUND CREW. 4 MINUTE TIME LIMIT. PROGRESSIVE AFTER TIMES ESTABLISHED FOR PAYOUT AND POINTS.

LADIES CALF BRANDING: SAME AS OVER 50 CALF BRANDING. 4 MINUTE TIME LIMIT.

POINTS SYSTEM: ALL AROUND AND WOMEN'S ALL AROUND WINNERS SHALL BE DETERMINED AS FOLLOWS: CONTESTANTS PLACING FIRST THROUGH FIFTH IN EACH EVENT SHALL BE ASSIGNED POINTS WITH 10 POINTS GOING TO FIRST PLACE, 9 POINTS TO SECOND PLACE, 8 TO THIRD PLACE, 7 TO FOURTH PLACE, AND 6 POINTS TO FIFTH PLACE.
